**Yog Vidya Dham, Satara**, a Academy duly organized and existing under the laws of India having its registered **Shreejay Appt. Juna RTO Chouk, Near Kadam Bag, Satara- 415001** hereafter referred to as “**Yog Vidya Dham, Satara**”, which expression shall unless repugnant to the context or meaning thereof, include its successors, legal representative and permitted assignees) on SECOND PART AND WHEREAS, **Prof. Sambhajirao Kadam College, Deur** is offering UG program in Arts, Commerce, Science, CC and B.Voc. AND WHEREAS, **Yog Vidya Dham, Satara** is a registered company, engaged in AND WHERE both **Prof. Sambhajirao Kadam College, Deur** and **Yog Vidya Dham, Satara** are desirous of associating with each other to expertise students of **Prof. Sambhajirao Kadam College, Deur** on Yoga, meditation, health awareness programme conducting Expert Lectures/Seminars/Workshops/ Consultancy (keep appropriate) as an addition **Prof. Sambhajirao Kadam College** curriculum in co-ordination with **Prof. Sambhajirao Kadam College** Faculties & HoD.

Now therefore, in consideration of the premises and the actual covenants herein contained, it is agreed by both **Prof. Sambhajirao Kadam College** and **Yog Vidya Dham, Satara** as under.

### 1.0 Definitions and Interpretation

1.1 “MOU” shall mean this Memorandum of Understanding executed between **Prof. Sambhajirao Kadam College, Deur** and **Yog Vidya Dham, Satara** on 21/12/2020.

1.2 “Party” or “Parties” shall mean **Prof. Sambhajirao Kadam College, Deur** and **Yog Vidya Dham, Satara** individually and collectively as the context may require:





The headings/subheadings/titles sub-titles are only for the sake of convenience and shall not be interpreted to restrict or otherwise affect the meaning or import of the clauses, which shall be interpreted solely in light of the contents thereof.

1.4 Use of words in the singular includes the plural and vice versa and the masculine gender includes the feminine where applicable.

1.5 Where a word or phrase is defined, other parts of speech and grammatical forms of that word or phrase shall have the corresponding meanings. Any reference to 'Writing' includes printing, typing, lithography and other means of reproducing words in visible form.

## 2.0 SCOPE OF THE MOU

Both **Prof. Sambhajirao Kadam College, Deur** and **Yog Vidya Dham, Satara** shall encourage interactions between Yoga, meditation, health awareness programme conducting Expert Lectures/Seminars/Workshops/ Consultancy faculty members and students of both the organizations through the following arrangements:

2.1 Organization of joint conferences and seminars;

2.2 Practical training of Prof. Sambhajirao Kadam College, Deur students at **Yog Vidya Dham, Satara**

2.3 Joint guidance of student projects/thesis in TO BE INTRODUCED HERE and other areas of national interest at Prof. Sambhajirao Kadam College, Deur by **Yog Vidya Dham, Satara** on mutually agreeable terms.

2.4 **Yog Vidya Dham, Satara** may depute its personnel as visiting faculty at Prof. Sambhajirao Kadam College, Deur to teach any of the regular Course or specialized topics.

2.5 **Yog Vidya Dham, Satara** may seek assistance/guidance of Prof. Sambhajirao Kadam College, Deur faculty member/s in product/process modification, modernization, trouble shooting, etc.

2.6 Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.

2.7 **Yog Vidya Dham, Satara** may showcase its business activities at the seminar/workshop/conference, etc. at Prof. Sambhajirao Kadam College, Deur

### 3.0 Responsibility Structure

3.1 Prof. Sambhajirao Kadam College, Deur shall provide the infrastructure of systems, LCD projector etc. for the Expert Lectures. Also the labs and other research equipment available in the lab.

3.2 **Yog Vidya Dham, Satara** shall be responsible for arrangements & coordination for encourage interactions between the Yoga, meditation, health awareness programme conducting Expert Lectures/Seminars/Workshops/ Consultancy faculty members and students Expert Lectures as well as Visits in co-ordination with staff & HoD Prof.Sambhajirao Kadam College, Deur

3.3 Prof. Sambhajirao Kadam College, Deur shall create awareness amongst its students for promotion of the activity especially Competitive Examination.

### 4.0 Certification

4.1. Upon completion of the Internship, **Yog Vidya Dham, Satara** & Prof. Sambhajirao Kadam College, Deur will jointly conduct technical assessment for students. The students qualifying the technical assessment shall be certified with completion certificate.

### 5.0 Relationship

This MOU relates solely to the intention of the parties, wherein **Prof. Sambhajirao Kadam College, Deur** and **Yog Vidya Dham, Satara** jointly work together and shall not extend to any other activity or create a partnership between the Parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in their respective fields, except to the extent expressly provided herein.

### 6.0 Authority to Bind

No party shall act on behalf of the other party to contractually bind the other Party under the terms of this MOU having first obtained the other Party's written agreement.





## Confidential and Proprietary Information



“Confidential Information” shall mean all information, including the material and written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by **Yog Vidya Dham, Satara** and disclosed by **Yog Vidya Dham, Satara** to **Prof. Sambhajirao Kadam College, Deur** or its faculty which is related to **Yog Vidya Dham, Satara** information such as course material, training data, guidance notes, procedures, methodology, etc.

7.2 **Prof. Sambhajirao Kadam College, Deur** shall not disclose Name of the Company confidential information without first obtaining written consent from **Yog Vidya Dham, Satara**

## 8.0 Termination

05 year from the date of signing of MOU, unless renewed on a mutually agreed terms and condition for a further period. During the initial term or any renewal term, either party may terminate this MOU, after mutually agreed days, with prior written notice to the other party.

## 9.0 Assignment

This MOU shall not be assigned or otherwise transferred by any Party, in whole or in part, without the express written consent of the Other Party.

## 10.0 Consequential Damages

Other than explicitly mentioned in this MOU, either Party shall not under any circumstances or at any time be liable to the other under or in connection with the MOU for any special or any direct or indirect loss or damage or for any consequential loss or damage, whether direct or indirect, including but without limiting the generality of the foregoing, loss of profits, loss of production, or loss of opportunities.

## 11.0 Severability

If any provision of this MOU or the application thereof to any person, entity or circumstance shall be invalid or unenforceable to any extent, the remainder of this MOU shall not be affected thereby and the application of such provision shall be enforced to the greatest extent permitted by law.



All disputes, differences or claims arising out of or in relation with this MOU but inclusive of as regards to rights, liabilities, damages, claims, breach or termination of this MOU between the Parties shall be referred to arbitration.

12.2 Any party shall give a written notice to other party of existing such dispute, difference or claim. On receipt of such notice within 15 days, the Head of Institution of **Prof. Sambhajirao Kadam College, Deur** and Partner, **Yog Vidya Dham, Satara** or any other persons so nominated by the respective Parties, shall meet together and try to resolve such dispute, difference or claim amicably. If such amicable solution is not arrived within one month, then the matter shall be referred to Arbitration.

12.3 The place of arbitration shall be Satara. The arbitration proceedings shall be conducted in English as per the rules of The Arbitration and Conciliation Act 1996 by three (3) arbitrators appointed in accordance with the said Rules. The Arbitration Decision shall be final and binding.

### 13.0 Governing Law

The agreement shall be governed by Law of the Land.

### 14.0 Notices

14.1 Any notice and other communications provided for in the Agreement shall be in writing in English and shall be first transmitted by facsimile transmission and/or by internationally recognized courier service, in the manner as elected by the Party giving such notice: In the case of notices to **Yog Vidya Dham, Satara C/o Shreejay Appt. Juna RTO Chouk, Near Kadam Bag, Satara- 415001** and College Address : **Prof. Sambhajirao Kadam College, Deur, Tal. Koregaon, Dist.-Satara – 415 523**

14.2 Either Party may, from time to time, change its address or representative for receipt of notices or other communications provided for in this Agreement by giving to the other not less than 15 days prior written notice.

### 15.0 Entire understanding

This MOU expresses the whole agreement reached between the Parties. Consequently, this Agreement supersedes any previous letter or document of whatsoever nature exchanged between the Parties with respect to this Agreement.



**16.0 Waiver**

The waivers by one Party hereto of any default hereunder or of any covered agreement or condition contained herein shall not be construed to constitute a waiver of any other default or breach hereof whether similar or otherwise.

**17.0 Amendment**

No amendment to this MOU shall be valid and binding to the Parties unless it is made in writing and signed by authorized representative of all Parties to this Agreement.
