

- 8 You are required to give the correct mailing address as soon as you join the duties and any change in the address given earlier should be communicated to the Principal. It will be presumed that any letter sent by Registered Post Acknowledgement Due (RPAD) on the address given shall be deemed to have been acknowledge duly signed by you.
- 9 You will not conduct or engage yourself in any private tuition or private coaching classes.
- 10 You will not engage yourself in any other paid full time, part-time job or otherwise during your service without the prior permission of the competent authority of the Management.
- 11 Your services are transferable to any other college / institutions run by the Management.
- 12 Your appointment may be terminated at any time by either side / party, by giving one month notice or one month pay in lieu of notice period in case the period spent in service is more an six months.
- 13 If you are found absent continuously for more than thirty days without permission, your service stands terminated automatically. If you are found guilty of violation of any terms and conditions mentioned above, you will be liable for disciplinary action and punishment as decided by the Management as provided in the Statutes. During the period of your service you shall not directly or indirectly do such things which are subversive to the interests of the Government / University /Institute / Management / College / Students / Society.
- You have to communicate your acceptance to the Management / College / Institution with 14 seven days from the date of receipt of this Order of Appointment, failing which your appointment is liable to be cancelled
