



## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is executed on Day, 05/02/2019

AND WHEREAS, Girisha Wealth Maker Pvt. Ltd., is a registered company, engaged in Share Market Training, Equities, Mutual Funds, Insurance, Derivatives, Currency etc. AND WHERE both Prof. SambhajiraoKadam College, Deur and Girisha Wealth Maker Pvt. Ltd. are desirous of associating with each other to expertise students of Prof. SambhajiraoKadam College, Deur on Financial Awareness, Share Market Training, Insurance, Currency etc. will also help in conducting Expert Lectures/Seminars/Workshops/Internship/Industrial Visits/ Consultancy as an addition Prof. SambhajiraoKadam College curriculum in co-ordination with Prof. SambhajiraoKadam College Faculties & HoD.

Now therefore, in consideration of the premises and the actual covenants herein contained, it is agreed by both Prof. SambhajiraoKadam College and Girisha Wealth Maker Pvt. Ltd. as under.

### 1.0 Definitions and Interpretation

1.3 The headings/subheadings/titles sub-titles are only for the sake of convenience and shall not be interpreted to restrict or otherwise affect the meaning or import of the clauses, which shall be interpreted solely in light of the contents thereof.

1.4 Use of words in the singular includes the plural and vice versa and the masculine gender includes the feminine where applicable.

1.5 Where a word or phrase is defined, other parts of speech and grammatical forms of that word or phrase shall have the corresponding meanings. Any reference to 'Writing' includes printing, typing, lithography and other means of reproducing words in visible form.

## 2.0 SCOPE OF THE MOU

Both **Prof. SambhajiraoKadam College** and **Girisha Wealth Maker Pvt. Ltd.** shall encourage interactions between the Trainer, faculty members and students of both the organizations through the following arrangements:

2.1 Organization of joint conferences and seminars;

2.2 Practical training of Prof. SambhajiraoKadam College students at Girisha Wealth Maker Pvt. Ltd.;

2.3 Girisha Wealth Maker Pvt. Ltd. may depute its personnel as visiting faculty at Prof. SambhajiraoKadam College to teach any of the regular Course or specialized topics.

2.4 Girisha Wealth Maker Pvt. Ltd. may seek assistance/guidance or share updates to Prof. SambhajiraoKadam College faculty member/s in **Share Market Training, Equities, Mutual Funds, Insurance, Derivatives, Currency, Commodities etc..**


2.5 Girisha Wealth Maker Pvt. Ltd. may avail library, Internet, computational facilities at Prof. SambhajiraoKadam College.

## 3.0 Responsibility Structure

3.1 Prof. SambhajiraoKadam College shall provide the infrastructure of systems, LCD projector etc. for the Expert Lectures. Also the labs and other research equipment available in the lab.

3.2 **Girisha Wealth Maker Pvt. Ltd.** shall be responsible for arrangements & coordination for supply of training programe, Process of necessary Appointments with Industries for Industry Internship Program, Expert Lectures as well as Visits in co-ordination with staff & HoD Prof. SambhajiraoKadam College.

3.3 Prof. SambhajiraoKadam College shall create awareness amongst its students for promotion of the activity especially Internship Program.



#### 4.0 Certification

4.1. Upon completion of the Internship, Girisha Wealth Maker Pvt. Ltd. & Prof. Sambhajirao Kadam College will jointly conduct technical assessment for students. The students qualifying the technical assessment shall be certified with completion certificate.

#### 5.0 Relationship

This MOU relates solely to the intention of the parties, wherein Prof. Sambhajirao Kadam College Girisha Wealth Maker Pvt. Ltd. jointly work together and shall not extend to any other activity or create a partnership between the Parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in their respective fields, except to the extent expressly provided herein.

#### 6.0 Authority to Bind

No party shall act on behalf of the other party to contractually bind the other Party under the terms of this MOU having first obtained the other Party's written agreement.

#### 7.0 Confidential and Proprietary Information

7.1 "Confidential Information" shall mean all information, including the material and licenses or other information if any so given to Prof. Sambhajirao Kadam College, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by Girisha Wealth Maker Pvt. Ltd. and disclosed by Girisha Wealth Maker Pvt. Ltd. to Prof. Sambhajirao Kadam College or its faculty which is related to Girisha Wealth Maker Pvt. Ltd. information such as course material, training data, guidance notes, procedures, methodology, etc.

7.2 Prof. Sambhajirao Kadam College shall not disclose Girisha Wealth Maker Pvt. Ltd. confidential information without first obtaining written consent from Name of the Company.

#### 8.0 Termination

During the initial term or any renewal term, either party may terminate this MOU, after mutually agreed days, with prior written notice to the other party.

#### 9.0 Assignment

This MOU shall not be assigned or otherwise transferred by any Party, in whole or in part, without the express written consent of the Other Party.

#### 10.0 Consequential Damages

Other than explicitly mentioned in this MOU, either Party shall not under any circumstances or at any time be liable to the other under or in connection with the MOU for any special or any direct or

indirect loss or damage or for any consequential loss or damage, whether direct or indirect, including but without limiting the generality of the foregoing, loss of profits, loss of production, or loss of opportunities.

#### 11.0 Severability

If any provision of this MOU or the application thereof to any person, entity or circumstance shall be invalid or unenforceable to any extent, the remainder of this MOU shall not be affected thereby and the application of such provision shall be enforced to the greatest extent permitted by law.

#### 12.0 Arbitration

12.1 All disputes, differences or claims arising out of or in relation with this MOU not limited but inclusive of as regards to rights, liabilities, damages, claims, breach or interpretation of this MOU between the Parties shall be referred to arbitration.

12.2 Any party shall give a written notice to other party of existing such dispute, difference or claim. On receipt of such notice within 15 days, the Head of Institution of Prof. Sambhajirao Kadam College and Partner, Girisha Wealth Maker Pvt. Ltd. or any other persons so nominated by the respective Parties, shall meet together and try to resolve such dispute, difference or claim amicably. If such amicable solution is not arrived within one month, then the matter shall be referred to Arbitration.

12.3 The place of arbitration shall be Satara. The arbitration proceedings shall be conducted in English as per the rules of The Arbitration and Conciliation Act 1996 by three (3) arbitrators appointed in accordance with the said Rules. The Arbitration Decision shall be final and binding.

#### 13.0 Governing Law

The agreement shall be governed by Law of the Land.

#### 14.0 Notices


