SHRI MUDHAIDEVI SHIKSHAN SANSTHA, DEUR

Deur, a small village in the hilly area, is situated on the bank of river Vasana. The Primary School established in the British regime in 1871 was the only source of education in this drought prone zone of the north Koregaon Tehsil. There were no other means of higher education in the village, until 1953, and the village youths had no other choice other than farming or working as a *mathadi* (labour) in Mumbai.

However, in 1953, some learned youngsters, with zeal to transform the native village, formed the Gram Jeevan Vikas Mandal. These dreamers soon started collecting funds by the means of donations, stage performances, arranging sports tournaments, screening film shows, etc. Later on, in the June, 1956 Shri Mudhaidevi Shikshan Sanstha, with its motto *Bahujan Hitay* (for the welfare of the masses), opened the doors of knowledge to Deur and its adjoining villages in the form of Shri Mudhaidevi Vidyamandir, the first high school in its vicinity.

Having the educational experience of six decades, the Sanstha is successfully running Shri Mudhaidevi Vidyamandir, M.K.Mane Junior College of Arts and Vocational Education, Junior College of Science, an English Medium School, and a Senior College [Prof. Sambhajirao Kadam College, Deur (Arts, Commerce, Science, Community College & B.Voc.)] in UG & PG courses in distance mode having an intake of more than 2000 students.

The Sanstha, by taking into consideration the pressing demands of the alumni and the stakeholders, has decided to include more PG courses, Diploma and Certificate courses in its perspective plan to cope-up with the need of time and is trying to get its sanction from the concerned authorities. Moreover, it is trying to augment its infrastructure by proposing the Ladies Hostel, Indoor Sports Gymnasium, separate Library and other required fixtures and furniture under its Development Plan.





PROF. SAMBHAJIRAO KADAM COLLEGE, DEUR

Established in 1999, Shri Mudhai Devi Shikshan Santha's Prof. Sambhajirao Kadam College, Deur (SATARA) is an 'A' Grade College by NAAC. It offers degree programmes in the faculties of Arts, Commerce and Science. श्री मुधाई शिक्षण संस्था, देऊर

पहाडों में बहती वसना नदी के किनारे देऊर गाँव बसा हुआ है। कोरेगांव तहसील के उत्तर दिशा में बसे इस गाँव में अंग्रेजी शासनकाल में इ.स.१८७१ में स्थापित मराठी पाठशाला ही शिक्षा का एकमात्र आधार थी। इ.स.१९५३ तक यहाँ पर उच्च शिक्षा की दूसरी सुविधा न होने के कारण यहाँ के युवकों को मुंबई जाकर मजदूरी करने के शिवाय दूसरा रास्ता नहीं था।

इ.स.१९५३ में गाँव का विकास करने के उद्देश से गाँव के पढ़े – लिखे नौजवानों ने 'ग्राम जीवन विकास संस्था' की स्थापना की। लक्ष्यप्राप्ति के लिए पागल बने इन नौजवानों ने चंदा इकट्टा कराने के उद्देश से नाटकों का मंचन करना, स्पर्धाओं का आयोजन करना, फिल्में दिखाना आदि कार्यक्रमों का आयोजन किया। जून १९५६ में देऊर तथा पडोस के गाँव के युवकों के लिए ज्ञानप्राप्ति का दरवाजा खोलने के उद्देश से 'बहुजन हिताय' इस आदर्श वाक्य के साथ 'श्री मुधाईदेवी शिक्षण संस्था' ने 'श्री मुधाईदेवी विद्यामंदीर' इस नाम से अपना पहला माध्यमिक विद्यालय शुरू किया।

पिछले साठ बरसों से यह संस्था कडी मेहनत, लगन तथा परिश्रम के साथ श्री मुधाईदेवी विद्यामंदिर, श्री एम के माने ज्युनियर कॉलेज (कला तथा व्यवसाय शिक्षण), ज्युनियर कॉलेज ऑफ सायन्स, इंग्लिश मेडियम स्कूल, प्रा.संभाजीराव कदम कॉलेज (कला, वाणिज्य, विज्ञान, कम्युनिटी कॉलेज तथा बी.व्हॉक.) और स्नातकोत्तर उपाधि द्वारा हर साल लगभग २००० छात्रों को पढाने का काम कर रही हैं।

यहाँ पर मिले ज्ञान के बलपर विद्यार्थी अपना उज्ज्वल भविष्य बना रहे हैं। उनकी इच्छा के अनुसार तथा समय की माँग को ध्यान में रखते हुए संस्था की ओर से विविध स्नातकोत्तर उपाधि, डिप्लोमा कोर्सेस तथा विभिन्न सर्टिफिकेट कोर्सेस शुरू करने के हर एक प्रयास शुरू हैं। साथ ही यहाँ पर पढनेवाले युवक-युवतीयों को हर एक सुविधा प्राप्त हो इस उद्देश से लेडिज होस्टेल, अत्याधुनिक जिम, बढियासी शैक्षिक सुविधाएँ तथा अलग से लायब्ररी आदि के लिए भी संस्था वचनबद्ध हैं।

1999 में स्थापित, श्री मुधाईदेवी शिक्षण संस्था के प्रा.संभाजीराव कदम कॉलेज, देऊर (सातारा), कला, वाणिज्य और विज्ञान के संकायों में डिग्री कार्यक्रम प्रदान करता है। पारंपरिक डिग्री कार्यक्रमों के अलावा, यह खाद्य प्रसंस्करण प्रौद्योगिकी, बागवानी और फूलों की खेती में कौशल आधारित व्यावसायिक डिग्री कार्यक्रम प्रदान करता है; और विश्वविद्यालय अनुदान आयोग की सामुदायिक कॉलेज योजना के तहत खाद्य प्रसंस्करण और संरक्षण, सौंदर्य और कल्याण में डिप्लोमा उपाधि प्रदान करता है।

Students shall undergo the internship and on the job training to be conducted in collaboration with relevant partner industry, business establishments and prospective employers.

- Inculcating professional skills leading to developing the skilled human resource of high caliber in the field of international trade, GST Laws; 2. Fostering core and professional competencies so as to enhance employability/ Self-employed professions, entrepreneurs in the emerging and highly rewarding fields, thus, catering to the needs of the economy, society and the county as a whole;
- Imparting learner centric training with a focus to overcome the apparently evident mis-match between the conventional curricula and industry required competencies; so as to make them capable of fetching gainful and sustainable employment in the field of international trade and GST Laws;
- 4. Preparing for competitive examinations conducted by UPSC, MPSC for the coveted government jobs such as IRS, Customs Officers, ITS/IAAS/IPTAFS/IES;
- Strengthening and harnessing on the collaborations with potential employers, industry, business establishments by way of conducting practical oriented session, offering internships/apprenticeships, on the job training and possible placements.

ADMISSION ELIGIBILITY AND RULES

Preamble

- In accordance with the provisions of the Maharashtra Public Universities Act 2016, the following rules shall be called the Admission Rules to be applicable to the nonprofessional under-graduate and post-graduate courses in the college.
- b) The admission rules for professional courses shall be as prescribed by the State Government from time to time. These rules have come into force from the Academic Year 2019-20 onward.

Undergraduate Courses:

- A.R.1 Admissions to non-professional undergraduates shall be strictly based on:
 - a) Eligibility criteria as prescribed by the University from time to time.
 - Reservation rules as prescribed by the State Government from time to time and adopted by the University.
 - c) Merit, as measured by the marks scored in the qualifying previous examination.
- A.R.2 The total intake capacity at the first point of the admission to the Senior College shall be divided as 80 per cent for the attached Junior College and 20 per cent for other Junior Colleges. However, in both cases the basic rules of merit, reservation & eligibility shall be applied. If 20 per cent quota remains unutilized, students from the attached junior college shall be admitted from the waiting list. The merit of the students from other Junior Colleges shall not be less than the merit of the last student admitted from the attached Junior College. In case, 80 per cent quota for the attached Junior College remains unutilized, the College shall have the right to admit students from other Junior Colleges subject to the general rules given above.
- A.R.3 In view of the problem of drop out, the additional 10 per cent of the sanctioned intake capacity may be admitted in the college subject to the general rules of the admission given above.
- A.R.4 In case of admissions to the second and third year of the integrated degree course, preference will be given to the students of the same college.
- A.R.5 There shall be an Admission Committee for the proper monitoring of admissions. After preparing the merit list, the merit list along with the waiting list shall be displayed on the college notice board/website for the information of the students.
- A.R.6 Husband/wife/son/daughter and brother/sister of both the teaching and non-teaching employees (on probation or confirmed) will be given admissions to the courses within a limit of 3 per cent of the total intake capacity subject to intra group merit considerations.
- A.R.7 In case of physically challenged students seeking admission to the first year of the integrated degree course the Admission Committee may use its discretion subject to the fulfillment of other conditions of admission.
- A.R.8 The foreign students shall be admitted to any course in the college on production of provisional eligibility certificate from the University.
- A.R.9 Cancellation of Admission and Refund of Fees and Non-Retention of Original Certificates (As per UGC Notification October 2018)
 - Cancellation of admission and refund of fees shall be as under:

- 3) Verification and non-retention of student's Academic and Personal Certificates:
- Students should not submit their original academic and personal certificates like Mark-sheets, Leaving Certificates and other such documents at the time of submitting their admission forms, but the submission of self-attested copies thereof will be mandatory.
- The college will physically verify original documents at the time of admission of the students in their presence and return them immediately after satisfying about their authenticity. The self-attested copies of the required documents will be kept for the official record.

The scheme is functional with the motto NOT ME BUT YOU in this college since its inception (1999). There are two functional units of NSS: (1) Added Unit having the strength of 100 Volunteers and (2) Self-Financed Unit having the strength of 150 Volunteers. The NSS activities are noteworthy and praiseworthy having prestigious State Level and University Level Awards and Recognitions to the Volunteers and POs.

Competitive Exam and Career Guidance Centre

Competitive Exam and Career Guidance Centre has been working since 2005. Its goal is to achieve the overall development of students. This Centre has been organizing various guidance lectures and hands-on-training programmes by eminent personalities for students. Separate reading space, library collection and expertise has been made available for the students aspiring competitive examinations.

Soft Skill Development Centre

By and large, the students, otherwise potentially able, coming from rural background lack abilities of expression, communication, presentation and for want of formal orientation of such soft skills, forfeit the job opportunities. Formal orientation and training towards developing soft skills would certainly help the students in getting employment. With this view, the college has established a Soft Skills Development Centre integrating it with Vocational Guidance and Placement.



Women Development Cell: (WDC)

Functional Women's Development Cell (WDC) formed with objectives such as promoting social awareness about the problems of women including gender discrimination, developing self-confidence, guiding them about Welfare Laws, highlighting the importance of health and hygiene and organizing seminars, workshops relating to women development. It has attempted to provide a proactive common platform for the women to debate, deliberate and execute plans and programmes for the holistic development of the women.

Dual Degree Programme (approved by Shivaji University)

Students can enroll for the dual degree programme approved by Shivaji University, Kolhapur. Faculty of Humanities, Commerce and Management, Faculty of Science and Technology and the Faculty of Interdisciplinary Studies.

Physical Facilities

Institute's main campus houses main building, gymnasium, canteen, and play fields. Under the physical and technology leveraged infrastructure, the institution has sufficient well-furnished smart classrooms, Science Laboratories, Commerce Laboratory and the Language Laboratory. 
