**Dear Teachers,**

***Teachers' Benevolent Fund (TBF) is a welfare scheme framed by the Shivaji University Teachers' Association (SUTA) and approved by Dy. Charity Commissioner, Kolhapur under Bombay Public Trusts Act, 1950.***

## **THE OBJECTIVES :**

- To try to render financial aid for the welfare of the family of the members of the Trust who die while in service as a teacher.
- To try to render financial aid to such members of the Trust who lose their job as a teacher due to physical or mental disability.
- To try to arrange medical camps at district levels or other places for the welfare of the members and their family as well as the public at large.
- To undertake such other activities as are considered desirable and necessary for the achievement of the objectives of the Trust.

## **MEMBERSHIP :**

- Membership is open to all Teachers ['Teacher' as defined in the latest University Act].
- There are two categories of Membership: i) Member and, ii) Associate Member.
- One Time Registration Fee Rs.1500/- (One Thousand Five Hundred Only) including Entrance Fee, Subscription, Premium and maintenance charges.
- Teachers, who are members of SUTA are eligible for Membership (i) of the Trust.
- Teachers, who are members of the Maharashtra Federation of University and College Teachers' Organization, are eligible for Associate Membership (ii).
- No Person suffering from any deadly diseases including Cancer, Tuberculosis, AIDS, Heart and others on the date of application will be considered eligible.
- Read Rules and Regulations of the Trust before enrolment.

### **BENEFITS :**

- Benefits can be claimed after completion of a year from the date of Membership.
- 40 times of the Premium Amount to the nominee in the case of Death.  
20 times of the Premium in case of losing a job due to physical or mental incapacitation caused by factors beyond control.
- The nominee shall be paid an additional compensation amount (as per the Resolution) for every completed year of the membership till death.
- The Member who loses his job due to physical or mental incapacitation shall be paid half of the compensation amount (as per the Resolution).
- Felicitation Gift for the Retired Members.
- Bonus applicable. (on the availability of funds)
- In case of Resignation, the Member shall lose all available benefits; however, he is entitled to get the Felicitation Gift.

### **LOSS OF MEMBERSHIP :**

- A Member will cease to be a member on his death OR resignation OR being adjudicated or adjudged insolvent OR convicted by a court of a criminal offence involving moral turpitude OR removal on the recommendation of the Board of Trustees / by the General Body or he leaves the jurisdiction of the Trust on a temporary or permanent basis.

### **NOMINATION :**

- On enrolling, the Member shall nominate his nominee(s) in the prescribed form.

### **DISPUTES & JURISDICTION :**

- Dispute, if any, comes under the purview of the Dy. Charity Commissioner, Kolhapur. The jurisdiction shall be the State of Maharashtra.
