According to this order grant is allowed for the faculty but in that faculty the number of students for first year is to be checked from university's ledger to make sure that it is correct/true after this grant is to be allowed.

 According to this order in each faculty first Second and third years each subjects students strength must be as follows according to GR No.NGC/1095/(5918)
 -3 19 June 1995 and GR Date 17 March 1999

1) Urban Part

24 Students

2) Tribal Part

10 Students

Colleges of rural parts and women colleges where population is below 50,000 and colleges of C class Municipality.

Join Director of higher education Kolhapur should make sure about the strength and the students as mentioned above before disbursing the grants of appointed teachers and each subjects.

- 2. Only granted divisions to be considered while distributing grants.
- 3. Considering the rules and regulations of Government posts of teaching and non-teaching faculty are to be created by the Join Director, H.E., in these granted colleges.
- 4. Grant is allowed for the College/faculty so the posts will be created and on those post surplus teachers are to be appointed as per Government Rules.
- 5. Before distributing grant to the college it is essential to make sure that affiliation of faculties and divisions.

- 6. All the appointed teachers and non-teaching employees should fulfill the conditions of service for their posts. For the faculty of teaching university approval is to be given. Reservation policy in case of reserved candidates must have been followed.
- 7. According to GR No.NGC/1277/122116/32/SL,21-9-77 and Circular No.NGC/1096/ 8158 /4126/VS-4,19/4/97 the D.D. of salary which is to be given to the college is to be deposited in bank/salary account. In the same bank the accounts of all the appointed faculties should have been opened All the same the salary of all servants is to be transferred on their account from the account of college Salary It is necessary to make sure about this process.
- 8. About grant/Permission/affiliation the said college has completed all the conditions of the government/university.
- 9. It is necessary for concerned colleges to implement all the orders issued by the government from time to time.
- 10. To make sure that the appointed servants are not doing job anywhere outside of this branch.
- 11. The institute has made available to the college its own bulding, classrooms and other facilities.
- By seeking the approval of the University to appoint regular principal through the University Selection Committee.
- 13. There should not be any complaint and judicial matters against the institute. The conditions and benchmarks as and when laid down by the government must be strictly implemented by the institute.
- 14. It is obligatory to the college which gets more than 25 lack grant in a financial year should make its audit according to C.A.G.(D.P.C.) Act, 1991, para (14).
- 15. According to GR.No.NGC 1093/(5918)/MS-3, 19/6/1995 while allowing workload, granted strength of students of a division is to be considered.
- 16. The subjects like Computer Science, Technology Science and similar subjects are approved as subjects at Science and Commerce Streams on Permanently Non-grant Basis. If universities have included these subjects in the proposals of new colleges or those colleges which already exist, these subjects should be considered to be approved on the Permenently Non-grant basis.

The amount which will be spent on the salary of above College is to be obtained from the finances of the year 2005-2006 However, if the provisions made by the District Planning and Development Board grant to be distributed.
